

FOR THE TERM OF OFFICE 2026-2030

The Rector of the University of Žilina (hereinafter referred to as the "Rector" and "UNIZA") in accordance with Section 10 (5) of Act No. 131/2002 Coll. on Higher Education Institutions and on the Amendment of Certain Acts, as amended (hereinafter referred to as the "Higher Education Act") and in accordance with Article 2 (5) of Directive No. 233 – Principles of Election of a Candidate for Rector and Acceptance of a Proposal for the Dismissal of the Rector of the University of Žilina (hereinafter referred to as the "Principles of Election of a Candidate for Rector", after approval by the Electoral Assembly on 1.12.2025, announces the election of a candidate for the Rector of the University of Žilina for the term of office from 03.07.2026 to 02.07.2030.

Pursuant to Section 10 (3) of the Higher Education Act and pursuant to Article 2 (1) of the Principles for the Election of a Candidate for Rector, a candidate for Rector is elected by an election assembly whose members are all members of the Academic Senate of the University and all members of the University Board of Trustees. The Electoral Assembly is convened and managed by the Chairman of the Academic Senate of the University of Žilina in Žilina (hereinafter referred to as "AS UNIZA").

Members of the academic community (individuals or groups) and members of the UNIZA Board of Trustees (hereinafter referred to as "SR UNIZA"), individuals or groups, have the right to propose a candidate for the Rector within the period specified in the election schedule, which is an integral part of this Decree.

Proposals for the inclusion of candidates for the Rector on the candidate list are submitted in writing to the members of the Election Commission in a sealed envelope marked "Proposal of the Candidate for the Rector of the University of Žilina in Žilina". The proposal must state the name, surname and titles of the candidate for the rector of the university and the name, surname, titles, date and signature of the applicant(s). The proposal may contain a maximum of one candidate for the Rector.

Nominations of candidates for the Rector can be submitted to the members of the Election Commission in person, through the registry or by post. In the case of personal delivery and submission of the application to the registry, the date of receipt is decisive, and in the case of sending the application by post, the proposal must be delivered to the university by the deadline for submission of proposals. Proposals received after the deadline are not taken into account.
