Decree Announcing the Election of the Candidate for the Dean Position of the Faculty of Operation and Economics of Transport and Communications

of the University of Zilina for the Office Period 2026-2030

Pursuant to § 13d of the Statute of the University of Žilina (hereinafter "Statute of UNIZA") and to § 9 part 10 of the Statute of the Faculty of Operation and Economics of Transport and Communications (hereinafter "FPEDAS") of the University of Žilina (hereinafter "UNIZA"), and under the approval of the electoral assembly, chairwoman of the FPEDAS Academic Senate

announces the election of the candidate for the dean position of the Faculty of Operation and Economics of Transport and Communications of the University of Zilina.

Pursuant to § 22, par. 2 of Act No. 131/2002 Coll. on Higher Education Institutions and Amendments to Certain Acts, as amended, and to § 13d of the Statute of UNIZA, and to § 9 part 6 of the Statute of the FPEDAS, the dean is elected by the electoral assembly, comprised of: a) representatives of the faculty's academia, and b) members appointed by the rector, in a number equivalent to ¼ of the total number of the electoral assembly. For the purpose of the electoral assembly, the representatives of the faculty's academia are the members of the Academic Senate of the FPEDAS. Pursuant to § 9 part 7 of the Statute of FPEDAS, the election assembly is convened and chaired by the Chairman of the FPEDAS Academic Senate. The whole process of the dean's election is governed by § 13d of the Statute of UNIZA and § 9 of the Statute of the FPEDAS.

The right to nominate a candidate for the position of the FPEDAS dean is reserved for the members of FPEDAS and UNIZA academia (either as an individual or a group) within the time period specified in the Election Schedule. The nomination may put forward only one candidate for the position of dean.

Candidates for the above-mentioned position shall be included in the candidates list after submitting the written nomination to the members of the electoral commission in a sealed envelope marked "Candidate's nomination for the position of dean of the FPEDAS".

The nomination must include the first name, surname, and academic titles of the candidate for the dean position, as well as the first name, surname, academic titles, date, and signature of the proposer/proposers. Nominations of candidates for the dean position may be submitted to the members of the electoral committee in person, via the UNIZA registry office, or by post. For nominations delivered in person or submitted via the UNIZA registry office, the decisive factor is the date of receipt; for nominations delivered by post, the nominations must be delivered to the university by the deadline for submitting nominations. A member of the electoral commission is obliged to inform chairwoman of the FPEDAS Academic Senate electronically about the acceptance of each nomination. Nominations submitted after the deadline shall not be accepted.
